





Riddell Centre Emerging Cancer Scholar Award for Cancer Immunotherapy

Purpose of Award

The Riddell Centre Emerging Cancer Scholar Award for Cancer Immunotherapy are competitive internal awards that recognize exceptional graduate students within the Riddell Centre for Cancer Immunotherapy, a research centre within the Arnie Charbonneau Cancer Institute, University of Calgary, who are conducting innovative and impactful research related to the Centre's research priorities, as described below. By providing financial support and encouraging pursuit of external funding, the award aims to foster the development of future research leaders and strengthen the Institute's training environment in Cancer Research.

The Riddell Centre's research priorities include:

- Developing novel cell and immune-based therapies for hard-to-treat cancers
- Enhancing the effectiveness and safety of cancer immunotherapies
- Advancing new treatment approaches through clinical trials
- Training scientists and clinicians to excel in the cancer immunotherapy field

Eligibility Criteria

- Current full-time PhD or MSc students at the University of Calgary whose primary supervisor is a current member of the Riddell Centre for Cancer Immunotherapy and the Arnie Charbonneau Cancer Institute
- Fulfills the Graduate Award Competition eligibility criteria (https://grad.ucalgary.ca/awards/award-guide/step-1-applying/eligibility)
- Open to all students; no citizenship restrictions

Number of Awards: determined by available funding

Value and Duration from the Riddell Centre Emerging Cancer Scholar Award for Cancer Immunotherapy:

- PhD \$20,000/year for up to 2 years
- MSc \$17,500/year for up to 1 year

Funding Expectations:

Award recipients are **required** to apply for all internal and external funding for which they are eligible, including those from provincial and national agencies.

Adjustments of Awards:

Reporting Requirements:

A final report must be submitted detailing knowledge translation outputs, external scholarship applications and awards received.

Application Instructions

Applications are administered by the Graduate Award Competition (GAC), available online, through your Student Centre. Please follow all guidelines and application deadlines for the GAC.

Required Components:

All components of the Standard GAC Award Application and CSM Harmonized Form must be completed.

Include an **eligibility statement** (max. 400 words) describing how your research aligns with the purpose of the Riddell Centre Emerging Cancer Scholar Award for Cancer Immunotherapy (see Purpose of Award).

Adjudication Process and Evaluation Criteria

Eligible applications will receive a primary score through the GAC review process. This is a multi-disciplinary group of reviewers who may not have the in-depth knowledge in all the projects they review. Applicants must ensure that their project proposals can be understood by a non-specialist reviewer.

The top 50% of the applications will be re-evaluated by the Charbonneau Training Review Committee and adjudicated based on the following criteria:

- Relevance and contribution to advancing the Riddell Centre's research priorities (see above)
- Significance and quality of the proposed project
- Strength of the candidate (e.g., academic excellence, research experience, awards)

The Charbonneau Training Review Committee will make recommendations for funding to the Riddell Centre's Educational Lead and Leadership Team, who will select to successful applications based on the criteria listed above.

Award Terms and Obligations

Awarded recipients and their supervisors agree to the following obligations:

Acknowledgment of Support:

All publications, presentations, and communications related to the funded research must acknowledge support from the Riddell Centre Emerging Cancer Scholar Award for Cancer Immunotherapy and Arnie Charbonneau Cancer Institute.

Participation in Training Activities:

Awardees are required to participate in training activities, such as courses, workshops, and professional development opportunities organized by the Riddell Centre for Cancer Immunotherapy_and the Arnie Charbonneau Cancer Institute.

Continued Application for External Funding:

To enhance the training capacity of the Riddell Centre for Cancer Immunotherapy and the Arnie Charbonneau Cancer Institute, all awardees must actively seek external funding opportunities.

Notification of Awards:

Recipients must inform the Riddell Centre for Cancer Immunotherapy and the Arnie Charbonneau Cancer Institute of any awards received from external or internal agencies or programs during the term of their award.
